On 03/24/2021, a Form 17 (attached) was completed with a beginning pressure of 360 psi. Chevron will plumb the surface casing into the flowline as is seen on the attached diagram by 08/01/ 2021. This will maintain the pressure below the 316 psi limit as flowline pressure ranges from ~80-145 psi.
