On 4/28/2021, a Form 17 was completed with a starting pressure of 21 psi and an ending pressure of 0 psi. During the test water began to flow at the 10-minute mark and continued to flow until 27 minutes into the test. A water sample was collected, those results will be submitted once the lab has finished their analysis. Due to the water flow during the test, we are electing to plug this well. This well is located in a floor irrigated corn field; therefore, we are requesting to plug this well by 12/31/2021. We will continue to monitor and blow down as necessary until the well has been plugged.
