 On Thursday 5/13/21 at approximately 13:00 hours, I, Inspector Corey De Paolo, Conducted, a follow up inspection at TEP ROCKY MOUNTAIN LLC SPECIALTY RESTAURANTS-67S96W /33SWNW, Location #383330 in Garfield County Colorado.  
 Refer to document #699802767 inspection conducted on 3/15/21. Previous corrective actions have not been completed. While there, I observed normal production operations.  
 During this inspection the following compliance issues were observed:

- 1) No battery sign located at the tank battery with a corrective action date of 8/13/21.
- 2) Location lacks stabilization. No form of tracking BMP at entrance to location with a previous corrective action date of 3/30/21..

- Location is located in a high priority habitat area.

A follow up on this site inspection needs to be conducted to ensure the Compliance issues have been corrected to comply with COGCC rules. This is a summary of inspection report.
