COMMENTS:

Noble Energy respectfully requests continued TA status. The well is closed to the atmosphere via a sand plug set at 5981' on 4/6/1994. The well is closed to the atmosphere and locked out at the master valve. The well was completed in the Niobrara-Codell formation. This well was TA'd for P&A. Noble began the re-entry P&A job when setting the plug but ran into difficulties and is now on Noble's problem well list. Additional downhole plugs were placed during P&A, please refer to attached wellbore diagram for details of current configuration. This well is tagged with a blue tag. The current bradenhead pressure is 0 psi BH. Noble will continue to monitor wellbore conditions, provide a monthly report out and prioritize wells for re-entry.
