Comment:

The access road and location have not been recontoured and reclaimed. There are pipe risers, equipment, and debris that remain. All equipment and debris should have been removed within 3 months of plugging the well. A shallow pit remains at the south side of the location. There is erosion along the cut and fill slopes of the location which have created gully erosion. The soils are compacted and bare of vegetation and there are noxious weeds. Previous inspection corrective action has not been completed. The corrective action date is set for when final reclamation was required to be completed. Corrective action needs to be performed immediately to obtain compliance.
