Interim reclamation is not conducted per COGCC rules. Operator and USFS discussed re-seeding for stabilization on cut-slope and fill slopes as well as treatments for cut-slope stabilization. These will be assessed after installation.

Corrective Action

Per Form #402218033 construction began on 10/25/2019. Therefore, interim reclamation should have been conducted no later than 10/25/2020. It was discussed at this meeting that Catmaount is waiting on drilling permits. Therefore COGCC communicated that a variance to delay interim reclamation will be needed. This communication was also emailed to the operator and consultant on 5/27/2021. Operator needs to submit variance or conduct interim reclamation. Corrective action is back-dated to date that interim reclamation was due.

Comment: Stormwater controls are installed in response to 2020 reclamation inspection. However erosion continues in the western project area. Per onsite conversations with Catamount and USFS, Catamount plans to install BMPs including a rock apron, slope stabilization down-slope from the rock apron, and a silt trap at the western discharge point. Additional silt trap at the bottom of the cut-slope drain and above culvert is planned.

Corrective Action: Corrective action for stormwater is back-dated to original corrective action date. COGCC will assess the effectiveness of stormwater controls after installation.
