INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

This form has been prepared to provide prior notice of the plugging and abandonment of the Williams 18-29, 36-20 wells and associated flowlines. The flowlines will be temporarily abandoned in place. In accordance with COGCC Rule 911.a., soil samples and a groundwater sample (if present) will be collected following excavation at the wellheads and following removal of the flowlines to determine if soil and groundwater (if present) meet the concentration levels of COGCC Table 915-1. Field screening of soil will be conducted during sampling activities. Soil vapor screening will also be performed around the wellheads. The topographic Site Location Map showing the geographic setting of the site is provided as Figure 1.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

Following excavation at the Williams 18-29, 36-20 wellheads, discrete grab soil samples will be collected from the excavations. The soil samples will be field screened for total volatile organic compounds using a photoionization detector (PID). If field screening does not indicate impacts to soil in any of the wellhead excavations, only the base soil sample will be submitted for laboratory analysis. If impacts to soil are observed in any of the wellhead excavations or in the flowline excavation, the soil samples exhibiting the highest degree of impact will be submitted for laboratory analysis. Soil samples that are submitted for laboratory analysis will be run for the full list of analytes for soil in Table 915-1. The proposed soil screening and sampling locations are depicted on Figures 2 and 3.

Proposed Groundwater Sampling

Will groundwater samples be collected as part of this investigation? (Number, analyses, and locations of samples):

If groundwater is encountered during excavation activities, a minimum of one grab sample will be collected from the excavation (if present) as soon as practical and submitted for laboratory analysis of the full list of analytes for groundwater in Table 915-1.

Additional alternative investigative actions described in attached Site Investigation Plan (summary):

Following excavation activities, a maximum of five shallow soil vapor screening points will be installed around each of the Williams 18-29, 36-20 wellheads. Two shallow soil vapor points will be installed in the base of the proposed excavation at each wellhead, and three will be installed outside the extent of the proposed excavation around each wellhead. The proposed shallow soil vapor points are depicted on Figure 2.
