Attention Chris Binschus:

A Form 10 Change of Operator has been submitted under the Location ID. The associated centralized facility is permitted separately (Loc ID 467698) and remains in place for the producing BOOTH # 25-32 Well (Loc ID 330932, API: 05-123-19894). No permanently stabilized access road was constructed for the site; the location was accessed off CR 54 leading north to the site and west from 95th Avenue. All portions of the disturbance, including the egress corridors have been successfully reclaimed and returned to cropland. Please see the attached report for additional reclamation activities, details on the completed reclamation assessment, and photo documentation.
