- Rutting from bottom of road incline to location a top of hill. Rutting is a sign of lack of compaction. Rutts on step grade creates washing and rilling pathways. Ditch on road up to location has sediment sloughing into it and causing washing into shoulder of road. Stock pile of bermed material on location. Berm is not maintained, weeds growing inside of berm. Inspector not clear of what stock pile is.

A follow up on this site inspection will be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
