Inadvertently the Form 17 documenting the test was never submitted. Proper documentation of this test was submitted on 1/27/2021 and approved (Document No. 402584839).
The bradenhead was checked at the time of the weed cutting and no pressure was present. The bradenhead is cemented back to surface at the #1 Muegge Hand 41-31.
