 Field Inspector Actions:
 On 6-1-2021, I Randy Silver area field inspector was assigned a complaint received by COGCC staff in reference to noise. The complainant Todd Schulz 16654 Poplar Ct Brighton CO stated the issues were occurring outside of complainants home.
 On 6-2-2021, I attempted to make contact with the complainant who indicated that on 5-31-2021 he stated hearing noise form a pump jack that ran continuously 24/7 to the east of his residence.
 I performed a complete site inspection of the oil and gas location and associated wells in the area. At time of inspection, I performed a sound study. I could not set up a 24 hr study due to livestock in property. I performed a 1 HR test 350ft from the Pumping motor between source of noise and residents home. At time of inspection, sound levels were within COGCC rules.
