COMMENTS:

This well was brought back online 5/5/2021 and BH pressure was observed. A Form 17 was conducted on 5/5/2021 with a BH pressure of 125 PSI and sustained continuous gas flow. A production and BH gas were collected and will be submitted via form 43.

The casing and tubing were then sold to kill the well in the event BH pressure was the result of a casing failure. We were able to kill the well and the BH has not reached 50 PSI since. As a result of these findings we plan to P&A the well in 2021.
