Verdad is the surface owner, the consultation date is the same as submit date.

The closest well in the same formation is the Countyline 3130-06H and is measured in 2D.

This well has a bottom-hole location beyond the unit boundary setback. The bottom of the completed interval will be within the unit boundary setback at 460 FNL and 897' FEL of Section 30. The wellbore beyond the unit boundary setback will be physically isolated and will not be completed.
