CIBP set at 7474' topped with 2 sxs of cement and CIBP set at 6684' topped with 2 sxs of cement. Pressure tested to 2060 PSI for 15 Minutes, safety shut in with a 5K wellhead for Oxy's Jodster North 8-25 offset Fracs. Surface equipment has not been removed from the location. PDC intends to return this well to production once the offset fracs are complete and requests continued TA status.
