OPERATOR COMMENT

Facility # 114679 was attributed as an oil and gas pit facility based upon assumptions during inspections and aerial images, as per the notes on 114679's dashboard. The pit and a stock tank were originally constructed by the landowner and have remained wholly under the landowner's control for the duration of its existence. COGCC has repeatedly requested Investment Equipment sample, maintain, and close the landowner's pit. An attestation of the landowner's ownership of the stock tank and pit was submitted to COGCC on March 11, 2016, Document # 2211900 (attached), yet the COGCC continues to assume Investment Equipment's ownership of this facility and requires Investment Equipment to maintain or close the facility.

The landowner has tired of the interference with his facility and has retained legal counsel to enforce his rightful ownership of the facility and will cease allowing any access for Investment Equipment to perform any work at this facility. Soil samples gathered by Investment Equipment have shown all soils are in compliance with COGCC Table 915 and respectfully requests the closure of this remediation project as well as removing the pit from Investment Equipment's COGCC obligated facilities.
