Operator will provide notice to COGCC EPS Kari Brown (kari.l.brown@state.co.us) at least 48 hours prior to backfill or any sampling events performed on location. Note that samples collected must be analyzed for Table 915-1 parameters.

Form 27 Doc #402653879 (4/9/2021) notes "The excavation was backfilled before samples were taken to confirm clean up at the landowners request to cattle in the pasture."

COGCC Supervisor: Submit the required documentation as required by the CA. Submitting a Form 27 without the requested information does not resolve the corrective action.
