Noble Energy respectfully requests continued TA status. The well is closed to the atmosphere via a CIBP set at 6898 on 4/30/2019. The well is closed to the atmosphere and locked out and tagged out at the master valve. The well was completed in the Niobrara-Codell formation. This well was TA'd for an off-set frac, Extraction Oil and Gas's Wake East 33E-20-17C Pad. Noble will return the well to production or plug and abandon before the next MIT is due. Noble is currently working through a large back log of P&A work for offset mitigation work for DJ basin activity. Form 5A to change the status to TA was submitted on doc# 402081962. Successful MIT was performed on 9/9/2019 and submitted on doc# 402174140. This well is tagged with a blue tag.
