Comment:

Traffic, using road through Location is now excluded from former Pad area, and gate is locked that allows traffic access through site to service Irrigation structures at river. Debris (old cable) & Equipment (Anchors) have been removed. Portions of Location appear compacted, with weeds, the only emergent vegetation. A Northeast portion of site is revegetating, though debris weeds are also established.
 As in Previous Insp:
 Form 27(S) submitted by Operator, states that surface soils were tilled and seeded with Surface Owner approved seed mix; if completed these activities have been unsuccessful.

Corrective Action:

Assess vegetation and site conditions. Apply remedies /conduct reclamation activities needed, as indicated by assessment to ensure the uniform establishment across the site of desirable vegetation. Reclamation Activities to be complete by November 15, 2021.
