The well is closed to the atmosphere and locked out and tagged out at the master valve. The well was completed in the Niobrara-Codell formation. This well was TAd for an off-set frac, Nobles WELLS RANCH STATE AA36-643 Pad. Noble will return the well to production or plug and abandon before the next MIT is due. Noble is currently working through a large back log of P&A work for offset mitigation work for DJ basin activity. Form 5A to change the status to TA was submitted on doc # 402115812. A successful MIT was ran on 08/29/2019, doc # 402155079. This well is tagged with a blue tag.
