<p>Following cut and cap operations on June 10, 2021, a confirmation soil sample (WH-B01@6') was collected from the base of the wellhead cut and cap excavation area and submitted for laboratory analysis of benzene, toluene, ethylbenzene, total xylenes (BTEX), naphthalene, and total petroleum hydrocarbons (TPH) - gasoline range organics (GRO: C6-C10) by United States Environmental Protection Agency (USEPA) Method 8260D, TPH - diesel range organics (DRO: C10-C28) and oil range organics (ORO: C28-C40) by USEPA Method 8015D, pH, specific conductance (EC), and SAR by saturated paste method, and boron by hot water soluble soil extract method. Analytical results indicated that constituent concentrations in soil sample WH-B01@6' were in compliance with the COGCC Table 915-1 standards, with exception to the pH result. Excavation and assessment activities are ongoing and will be summarized in a forthcoming Form 27-Supplemental Site Investigation and Remediation Workplan under Remediation Project No. 18346 (approved Form 27 Document No. 402701722). Based on the analytical results for sample WH-B01@6', confirmation soil samples will be analyzed for pH by saturated paste method. A topographic Site Location Map showing the geographic setting of the release is provided as Figure 1. Soil sample location and field screening data is provided in Table 1. Field notes and a photographic log are provided as Attachment A. The State Notification email is provided as Attachment B.</p>
