Comment:

It was observed in this inspection that corrective actions from inspection #696201869 and final reclamation activities have been performed; observed debris/equipment/etc... have been removed; revegetation activities evident.

Final reclamation is in process, perennial germination evident, however due to current drought conditions additional future seeding activities may be necessary to ensure reclamation progresses towards COGCC 1004 Standards.

Additionally, vegetation establishment observed is predominantly undesirable weedy plant species that may hinder reclamation without weed management.
