WELL WAS ORIGINALLY SHUT-IN FOR HZ SAFETY PREP. RBP @7,130' AND RBP SET @ 7,040 WITH 2 SACKS CEMENT ON 10/29/2018 .PRESSURE-TESTED CASING TO 1,000 PSI FOR 15 MIN. A MECHANICAL INTEGRITY TEST WAS PERFORMED TO ENSURE INTEGRITY OF CASING ON 4/2/2020 AND PRESSURE-TESTED TO 350 PSI FOR 20 MIN. TA STATUS PROVIDED VIA DOWN-HOLE PLUG AND SURFACE ISOLATION PROVIDED VIA CLOSED MASTER VALVE. KERR-MCGEE IS WORKING THROUGH A LARGE INVENTORY OF P&A WORK. KERR-MCGEE PLANS TO PLUG A TOTAL OF ABOUT 230 WELLS IN 2020, 350 WELLS IN 2021. THUS FAR, OPERATOR HAS PLUGGED ABOUT 215 WELLS IN 2020 AND WILL CONTINUE WORKING TOWARDS OUR TARGET.
