Operator Comment: BMPs have been installed and/or repaired per Rule 1002.f.(2)C. TEP has researched the origin of the soil
material contained within an earthen berm at the location. Based upon this research, it appears that the soil was
excavated as a precautionary measure when a truck trailer tipped on its side on the access road leading to this
location in July 2009 (see attached pic). Records show there was no spill of fluids from the trailer associated with

the incident that occurred 12 years ago. The trailer tipped over due to a soft, poorly compacted section of the road where a water line was recently installed. After the trailer was emptied and removed, the hole in the road was excavated and repaired. It is believed the soils excavated are the soils that were placed in the berm at the PA 21-6 well pad. TEP staff collected a composite sample of the material and conducted a PetroFlag screen for hydrocarbon analysis. The results of the PetroFlag screen show that TPH levels were 73 ppm ... well below the 500 ppm cleanup threshold. This material is considered to be clean, non-contaminated soil and will be re-used.
