**COGCC Inspection Report Summary**  
On Tuesday 6/22/2021 at approximately 1300, I, Inspector Scott Ramsey, conducted a routine inspection at Caerus ELU 8905C-24 E24 396, at Location # 316505 in Garfield county Colorado.  
While there, I observed normal production operations. All meters have been calibrated on location within the past year. This location is within or in close proximity to a CPW Density/High Priority Habitat, black bear, NSO habitat and Wildlife Management Area. Operator (Caerus) has provided documentation of their Best Management Practices for Sediment Tracking Controls.  
During this inspection the following possible compliance issues were observed:  
1. Access road and location show signs of lack of stabilization/compaction and sediment traps along access need maintained  
2. Unused chemical pump and random debris  
3. Lack of battery signage  
4. Container (full of fluid) in front of tank battery has No labeling nor is it contained  
Refer to photograph of observed compliance issue.  
  
A follow up on this site inspection will be conducted to ensure the compliance issues have been corrected to comply with COGCC rules. This is a summary of inspection report.
