Proposed Procedure:

1. MIRU pulling unit. Pull 2 3/8" tubing.

2. RU wireline company.

3. TIH with CIBP. Set BP at 4237'. Top with 2 sxs 15.8#/gal CI G cement. (Top of Sussex @ 4287').

4. TIH with CIBP. Set BP at 2500'. Top with 2 sxs 15.8#/gal CI G cement.

5. Wait a sufficient time to confirm static conditions. If at any time after placing this plug there is evidence of pressure or fluid migration, contact engineering before continuing operations.

6. TIH with tubing to 1650'. RU cementing company. Mix and pump 126 sxs 15.8#/gal CI G cement down tubing. Cement should circulate to surface.

7. Cut surface casing 6' below ground level and weld on cap.
