COGCC Inspection Report Summary  
 On Tuesday 6/22/21 at approximately 13:00 hours, I, Inspector Corey De Paolo, Conducted an on-site inspection at TEP ROCKY MOUNTAIN LLC EXXON-67S95W /6SWNE, Location #334957 in Garfield County Colorado.  
 While there, I observed normal production operations.  
 During this inspection the following compliance issues were observed:

1) Location lacks stabilization. No form of tracking BMP at entrance to location. Rill erosion occurring in multiple places on location and access road. No velocity checks located in ditches. Sediment traps insufficient to control sediment migration off location. Sediment migration and gully erosions occurring downstream of location and access road BMP's with a corrective action date of 7/7/21.

- Location is located in a high priority habitat area.

A follow up on this site inspection needs to be conducted to ensure the Compliance issues have been corrected to comply with COGCC rules.
