Well Abandonment Report was submitted 7/1/2011 by North Finn LLC with date of Abandonment (Plugging Date) as 8/28/2010 noting in Comments "THE BREEZE 43-18 WILL NOT BE CEMENTED OR MECHANICALLY PLUGGED"; with notes referring to Land Owner Conversion to Water Well. F6s also reported "NORTH FINN HAS REMOVED THE RODS, TUBING, AND ALL ASSOCIATED PRODUCTION EQUIPMENT FROM THE WELL SITE".
