2. RU wireline company.
3. TIH with CIBP. Set BP at 6576'. Top with 2 sxs 15.8#/gal CI G cement. (Top of Nio perms @ 6626')
4. TIH with CIBP. Set BP at 2500'. Top with 2 sxs 15.8#/gal CI G cement.
5. Ran a Strip Log from 2500' to Surface (log not kept).
6. TIH with tubing to 1492'. RU cementing company. Mix and pump 125 sxs 15.8#/gal CI G cement down tubing. Cement circulate to surface.
7. Cut surface casing 6' below ground level and weld on cap.
