### INITIAL ACTION SUMMARY

Description of initial action or emergency response measures taken to abate, investigate, and/or remediate impacts associated with E&P Waste.

Wellhead cut and cap operations were completed at the Glens 2 wellhead location on April 5, 2021. Groundwater and impacted soil were not encountered in the wellhead cut and cap excavation. Visual inspection and field screening of soils around the well and the associated pumping equipment was conducted following wellhead cut and cap operations, and a soil sample was submitted for laboratory analysis to determine if a release occurred. The associated flowline was removed on March 26, 2021. A topographic Site Location Map showing the geographic setting of the site location is provided as Figure 1. Soil sample location and field screening data is presented in Table 1. The wellhead soil sample and field screening locations are illustrated on Figure 2. The flowline field screening locations are illustrated on Figure 3.

### PROPOSED SAMPLING PLAN

On April 5, 2021, a confirmation soil sample (WH-B01@7") collected from the base of the wellhead cut and cap excavation area at a depth of approximately 7 feet bgs. The soil sample was submitted for laboratory analysis of benzene, toluene, ethylbenzene, and total xylenes (BTEX), naphthalene, and total petroleum hydrocarbons (TPH) - gasoline range organics (GRO: C6-C10) by United States Environmental Protection Agency (USEPA) Method 8260D, TPH - diesel range organics (DRO: C10-C28) and oil range organics (ORO: C28-C40) by USEPA Method 8015D, pH, specific conductance (EC) and sodium adsorption ratio (SAR) by saturated paste method, and boron by hot water soluble soil extract method. A background soil sample (WH-BG01@7") was collected from native material adjacent to the excavation area. Analytical results indicated that constituent concentrations in sample WH-B01@7" were in compliance with COGCC Table 915-1 standards. Soil analytical results are presented in Tables 2 and 3.

On March 26 and April 5, 2021, visual inspection and field screening of soils was conducted at four sidewall locations within the wellhead cut and cap excavation area, four locations at the ground surface adjacent to the cut and cap excavation, and six pothole locations prior to flowline removal activities. Based on the inspection and screening results, hydrocarbon-impacted soil was not observed at the soil screening locations. As a result, no soil samples were submitted for laboratory analysis from these areas in accordance with the COGCC Operator Guidance for Oil & Gas Facility Closure document. Soil sample location and field screening data is presented in Table 1. Soil analytical results are presented in Tables 2 and 3. The soil sample and field screening locations are illustrated on Figures 2 and 3. The laboratory analytical report is provided as Attachment A. The field notes and a photographic log are provided as Attachment B.

Laboratory results indicate that constituent concentrations in the soil sample (WH-B01@7') collected from the base of the wellhead cut and cap excavation area were in compliance with COGCC Table 915-1 allowable levels; therefore, no soils were removed. The excavation area was backfilled and contoured to match pre-existing site conditions.

## **REMEDIATION SUMMARY**

Laboratory results indicate that constituent concentrations in the soil sample (WH-B01@7') collected from the base of the wellhead cut and cap excavation area were in compliance with COGCC Table 915-1 standards. Groundwater was not encountered in the excavation. Based on the analytical data presented herein, assessment is complete at this site and no further activities are required. As such, Kerr-McGee is requesting a No Further Action (NFA) determination for this location.
