INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pit Facility #117395, which is the subject of this Form 27, appears to be a duplicate for pit Facility #101870, Remediation Project #15649, which has been approved for closure. Pit Facility #117395 is listed on the COGCC records as operated by Chandler & Associates. We have searched the COGCC data base and discovered Document #00657565 associated with Facility #117395. This document is an Application for Permit to Use Earthen Pit filed by Northwest Pipeline Corporation, gas purchaser at the time of the filing. The pit identified by COGCC as Facility #101870, operated by Locin, is the pit associated with the gas sales meter. This Facility #101870, Remediation Project #15649, has been approved for closure. Additional review of the COGCC database has identified the Pit Inventory provided by the previous operator, Chandler & Associates. This document #2224021 dated April 7, 2000 only identifies one pit and was assigned Facility #101864. Facility #101864, Remediation Project #15647 has been approved for closure. We have looked at Google Earth and made a site visit of the area. We have determined there were no additional pits at this well location other than the two pits that have been approved for closure, Facility #101870, Remediation Project #15649 and Facility #101864, Remediation Project #15647.
