Large area of west well pad is not in use and is in violation of Interim Reclamation rules. This was documented on COGCC Inspection 700600094 with a Corrective Action due date of 6/1/2020. As of current inspection, no action has been taken to perform interim reclamation of well pad. Corrective action date remains in effect.

An active non-reportable slow drip leak inside containment was observed from valve off of crude oil tank.
