On Wednesday 6/30/21 at approximately 14:30 hours, I, Inspector Corey De Paolo, Conducted an on-site inspection at TEP ROCKY MOUNTAIN LLC UNION-66S96W /33NWSE, Location #335237 in Garfield County Colorado.

While there, I observed normal production operations.

During this inspection the following compliance issues were observed:

- 1) No battery sign located at tank battery with a corrective action date of 9/30/21.
- 2) Location lacks stabilization. No form of tracking BMP at entrance to location with a corrective action date of 7/15/21.

- Location is located in a high priority habitat area. Additionally the location is approximately 370 feet from Parachute creek.

A follow up on this site inspection needs to be conducted to ensure the Compliance issues have been corrected to comply with COGCC rules. This is a summary of inspection report.
