INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

On March 31, 2021, field screening and confirmation soil sampling was conducted in accordance with the COGCC Rule 911 during the decommissioning and closure of the Anderson 12-13 Tank Battery (Figure 1). During decommissioning activities, a reportable release was discovered. Following the discovery, mitigation activities were initiated to delineate and remove remaining hydrocarbon impacts. During excavation activities, groundwater was observed in the excavations at approximately 6 feet below ground surface (bgs). Approximately 706 cubic yards (CY) of impacted material were removed and transported to the North Weld Waste Management Facility for disposal under PDC waste manifests.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

On April 1, 2021, one soil sample (SS03) was collected from the source area at approximately 4 feet bgs and submitted to Summit Scientific Laboratories for analysis of the full COGCC Table 915-1 analyte list. Preliminary analytical results indicate that site specific containments of concern (COCs) include BTEX, naphthalene, 1,2,4-trimethylbenzene (TMB), 1,3,5-TMB, naphthalene, TPH (C6-C36), anthracene, 1-methylnaphthalene (M), 2-M, arsenic, and selenium. Between March 31 and April 7, 40 soil samples (SS01 – SS30 and SS32 – SS41) were collected from the sidewalls and base of the excavation at depths ranging from 3 feet to 7 feet bgs and were submitted for laboratory analysis of the above referenced COCs. In addition, one sample (SS31) was collected at approximately 2.5 feet bgs was submitted for analysis of Table 915-1 soil suitability constituents. The final excavation extent and sample locations are illustrated on Figure 2. Analytical results are summarized in Tables 1 through 4

Proposed Groundwater Sampling

Will groundwater samples be collected as part of this investigation? (Number, analyses, and locations of samples):

On April 7, 2021, one groundwater sample (GW01) was collected from the excavation following source mass removal activities and submitted for laboratory analysis of BTEX, naphthalene, 1,2,4-TMB, and 1,3,5-TMB. Analytical results indicated that organic compound concentrations were in compliance with applicable COGCC Table 915-1 groundwater standards. The groundwater sample location is illustrated on Figure 2 and the analytical results are summarized on Table 5.

Additional Investigative Actions

Additional alternative investigative actions described in attached Site Investigation Plan (summary):

During initial closure activities conducted on April 27, 2021, soil encountered on site and below production equipment was visually inspected and field screened for volatile organic compound (VOC) concentrations using a photoionization detector (PID). Per the approved proposed soil sampling plan, samples were collected below and/or adjacent to the above ground storage tank (AST), separator flowline (SEP-FL), and produced water vessel (PWV). The samples were submitted for laboratory analysis of BTEX, naphthalene, 1,2,4-TMB, 1,3,5-TMB, and TPH (C6-C36). In addition, the excavation sidewall sample which exhibited the highest PID reading collected adjacent to the produced water vessel was submitted for analysis of Table 915-1 soil suitability constituents. Analytical results indicated that organic compounds and soil suitability constituents were in compliance with the applicable COGCC Table 915-1 Protection of Groundwater SSLs in all laboratory sample locations.

OTHER INVESTIGATION INFORMATION

Were impacts to adjacent property or offsite impacts identified?

Were background samples collected as part of this site investigation?

On March 31, 2021, one background soil sample (BKG01) was collected at approximately 2.5 feet bgs from native material topographically up-gradient of the tank battery and submitted for analysis of COGCC Table 915-1 metals. Analytical results indicated that arsenic, barium, and selenium were in exceedance of the applicable regulatory standards in native soil.

Was investigation derived waste (IDW) generated as part of this investigation?

Is further site investigation required?

Eight (8) monitoring wells will be installed via direct-push drilling methods to confirm the absence of dissolved-phase hydrocarbon impacts within and surrounding the former excavation extent. Lithologic descriptions and volatile organic compound (VOC) concentrations using a photoionization detector (PID) will be recorded for each borehole. If elevated VOC concentrations are encountered during the investigation, a sample will be collected from the interval exhibiting the highest VOC concentration from the borehole and submitted for laboratory analysis of BTEX, naphthalene, total petroleum hydrocarbons (TPH C6-C36), 1,2,4-TMB, and 1,3,5-TMB anthracene, 1-M, 2-M, arsenic, and selenium by EPA Methods 8260B and 8015. Proposed monitoring well locations are illustrated on Figure 3.

GROUNDWATER MONITORING

Based on the analytical data collected during source mass removal activities, PDC will conduct quarterly groundwater monitoring at the 8 proposed monitoring wells until closure criteria are met. Groundwater samples will be submitted for laboratory analysis of BTEX, naphthalene, 1,2,4-TMB, and 1,3,5-TMB by EPA Method 8260B in accordance with Table 915-1. In addition, site-specific inorganic parameters, including total dissolved solids (TDS), chlorides, and sulfates, will be evaluated at the source, up-and down-gradient monitoring wells during the third quarter 2021. Contingent on analytical results, inorganic parameter analysis will be discontinued after one sampling event.
