Comment: Noxious weeds remain established at site. Plants were in late stages of flowering and beginning seed head formation. Operator is advised that effective weed control usually requires several control applications, timing dictated by monitoring & application at growth stage when most susceptible to controls and before seed head maturity. Weed Contractor was working on ranch at time of inspection; there was evidence (wilting), that Location had been treated.
