**COGCC Inspection Report Summary**

On Tuesday 6/29/21 at approximately 14:00 hours, I, Inspector Corey De Paolo, Conducted an on-site inspection at LARAMIE ENERGY LLC Logan Wash /0796-16B Pad, Location #324445 in Garfield County Colorado.

While there, I observed normal production operations.

During this inspection the following compliance issues were observed:

- 1) No battery sign located at the tank battery with a corrective action date of 9/29/21.
- 2) Gully erosion occurring in ditches on both sides of access road. No form of velocity checks located in ditches with a corrective action date of 7/14/21.

- Location is located in a high priority habitat area. Additionally all drainages to the North NE contribute to Parachute creek and all drainages to the South SW contribute to the Colorado river.

A follow up on this site inspection needs to be conducted to ensure the Compliance issues have been corrected to comply with COGCC rules. This is a summary of inspection report.
