## COMMENTS:

The purpose of this COGCC Form 4 is to permit and document transportation of condensate impacted material from the RWF 13-31 well pad (COGCC facility #335487) to the PA 32-3 well pad (COGCC facility # 334647). The condensate impacted material was generated during remediation of a condensate spill that occurred on December 4, 2013 at the above mentioned RWF 13-31 well pad.

100 cubic yards of material was excavated from the impacted area and transported to the PA 32-3 well pad where the material will be managed on the pad surface; the pad's surface is owned by WPX Energy (see attached map for pad locations).

The impacted soil was spread out on the pad at a thickness of no more than 18 inches and bermed with clean material for stormwater control. A baseline composite sample will be collected in the spring of 2014 and will be analyzed for the entire Table 910-1 analytical suite. Further treatment of the soil will be based on the analytical results.

If the impacted material tests above the cleanup standards for organic compounds, it will be treated on location with a bioremediation product. After every treatment, confirmation samples will be collected and analyzed for constituents that exceeded the COGCC requirements.

If the pit material tests above the cleanup standards for the inorganic compounds, the material will be covered with a minimum of 3' cap during the final reclamation of the site.

Once the impacted material tests below the COGCC cleanup thresholds, it will be utilized for the PA 32-3 well pad maintenance. A form 4 will be submitted to COGCC with the analytical data along with the request to close the RWF 13-31 condensate release.
