#### COMMENTS:

This well started mitigation in January 2021. The pre-mitigation bradenhead test conducted 1/11/2021 (Form 17 doc# 402574530) reported 202 psi.

A production casing gas sample was collected on 10/9/2020 (Form 43 doc# 402587641). No bradenhead gas sample was collected due to insufficient volume. The production casing gas is composed of 72% methane and 13% ethane. A liquid sample was collected on 1/13/2021 (Form 43 doc #402585271). Compared to nearby groundwater well water quality measurements with total dissolved solids of 2310 mg/L, the liquid sample with 8800 mg/L indicates no communication between the surface casing and the surrounding freshwater aquifers.

Following the previous 6 months of Bradenhead blowdown mitigation, BCEI has seen progress with this well's Bradenhead but believes that it would benefit from an additional round of 6 month blowdown mitigation. This progress can be seen in the blowdown trends (charts attached). A bradenhead test was completed on 6/30/2021 with an initial surface casing reading of 25 psi (submitted via EHS Data Monster 7/11/2021). For these reasons, BCEI is confident in the efficacy of this mitigation program and is requesting that this mitigation plan be extended for an additional 6 months to further reduce average bradenhead pressure during buildup.
