**General Comment:**

On 6/17/21 COGCC staff, Kris Neidel inspected the Titanium well, pit 111692 is being closed as a part of REM project 15761 . Weather was 80 degrees and dry. No recent evidence of wildlife or livestock was present at the time of inspection. All production equipment has been removed from location. Material from pit has been stockpiled on pad surface. No obvious hydrocarbon staining was detectable in pit (smell or staining). COGCC has been told that the pit has been sampled. On the next quarterly report these results should be provided via Form 27. This remediation project should be completed no later than this fall. Stockpiled soil shall be removed immediately.
