The pit was historically back-filled by previous operator, soil samples will be taken and analyzed per Table 915-1 to ensure that this pit does not require any remediation prior to final reclamation on this location.

The backfilled soil will be excavated from the pit and disposed of at an offsite disposal facility (Rock Springs Landfill). It is estimated that the volume of soil to be disposed of is 20 cubic yards, although this will be determined in the field. In determining how deep to dig in excavating the operator will utilize field screening methods (PID). The estimated aerial extent is 25-ft x 25-ft and is likely greater than 15-ft bgs.
