COMMENTS:

During the Form 17 completed on 1/19/2021, a bradenhead and production gas sample was collected. Those results have been submitted via a Form 43 on 2/24/2021. A Form 4 for bradenhead mitigation was approved on 2/17/2021. The first blow down was on 3/5/2021, with a starting pressure of 66 psi, and collected 9.1 Mcf of gas for an approximate flow rate of 0.36 Mcf/minute and collected 0 gallons of fluid from the bradenhead but did not flow. The second blow down, on 4/1/2021, had a starting pressure of 57 psi, and collected 6.4 Mcf of gas for an approximate flow rate of 0.43 Mcf/minute, and collected 0 gallons of fluid from the bradenhead but did not flow. The third blow down, on 6/22/2021, had a starting pressure of 73 psi, and collected 10.2 Mcf of gas for an approximate flow rate of 0.29 Mcf/minute, and collected 0 gallons of fluid from the bradenhead but did not flow. On 7/1/2021, a Form 17 was completed with a starting pressure of 37 psi and an ending pressure of 0 psi. This well is in compliance with Order 1-232 and we request it be returned to annual testing.
