COMMENTS:

This well started mitigation in May 2021. The pre-mitigation bradenhead test conducted 5/28/2021 (submitted via EHS Data Monster 6/3/2021) reported 58 psi.

After diagnostics were conducted on this well's Bradenhead, it was determined that the pressure requires mitigation. BCEI will continue with a mitigation plan that involves four periods of Bradenhead blowdown to a catalytic convertor, separated by periods of at least 7 days of Bradenhead shut in. This will allow us to evaluate the profile of any pressure build-ups over a 6-month period of sequential blowdowns and draw conclusions from that data. After analysis was completed of the Bradenhead gas and compared with that of Production (Form 43 Doc# 402727046) gas, it is clear the Bradenhead gas is strongly microbial and biogenically sourced. The exceptionally high concentrations of methane in the Bradenhead do not resemble the composition of the production gas, BCEI believes that the biogenic sources of the Bradenhead gas will become exhausted over time given the prescribed mitigation strategies.
