COMMENTS:

This well was found to have 234 PSI on the BH test dated 6/14/2021 and did sustain continuous flow producing ~ 2.5 gallons total during test. A sample was collected and submitted via form 43 (doc #402740979).

We believe the BH pressure is the result of thermal expansion. We would like to remove a portion of liquid from the top of the surface casing annulus to provide room for expansion. After the planned procedure we will monitor the BH to ensure build up stays below 50 PSI. If pressure or flow persists, we would like to continue mitigation efforts (multiple fluid pulls) for up to 6 months and report back via form 17.

Initial displacement procedure was performed on 7/16/2021.
