COMMENTS:

As a result of the Form 17 bradenhead test performed on 5/19/2021 (Document ID: 402702772), Crestone Peak has added the Lumry 31-24 well to our monthly bradenhead blowdown schedule, due to bradenhead pressure greater than 50. The well is being blown down to 0 psi through our bradenhead test trailer. Crestone intends to perform this blowdown monthly for a total of six times and collect data. At the end of the data collection period, Crestone will propose further plans, as needed, to the Commission via Form 4 Sundry. While Crestone has calculated the blowdown emissions for the events and found them to be deminimis, all emissions are permitted under the new CDPHE regs. Crestone will analyze the data and work with the state engineer to implement BACT.
