Following the removal of the concrete vault, soil will be field screened to determine if impacts to soil are present. Five (5) discrete soil samples will be collected from the concrete vault was installed - each sidewall and base (~3 ft below ground surface) to verify soil was not impacted from the operation of the partially buried produced water vessel. Samples collected will be analyzed for Table 915-1 parameters.
