INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Foundation is planning to document conditions beneath all equipment at the Cure 11-33 well location (ID:304055) through observation and field screening when equipment is removed. Photos will be taken during removal of equipment and submitted on a Supplemental Form 27. Based on observations of staining or odor, Foundation will collect a minimum of one (1) soil sample from the area beneath each piece of equipment on location -- 1 wellhead, 1 produced water tank, 1 separator, and 1 meter shed.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

A minimum of four (4) soil samples will be collected as part of the facility closure investigation, collected after each piece of equipment is removed from the location. The samples will be collected at a depth of 6" below surface from areas showing the highest degree of impact (if apparent impacts are present), or from the areas outlined in COGCC's Rule 911.A.(4) Operator Guidance. A background sample will also be collected. If no indication of a release is present, samples will be analyzed for pH, SAR, EC, boron, naphthalene, 1,2,3 and 1,2,4 trimethylbenzene. If a release is discovered, samples will be analyzed for full COGCC Table 915-1.

This Supplemental Form 27 is being submitted to request closure of the Cure 11-33 well location (ID: 304055) and REM# 17986. All facility closure sample results indicate compliance with Table 915-1, with the exception of pH in the wellhead, separator, and meter shed samples. Consideration is being requested as the pH concentration is comparable to the background sample collected offsite.
