**General Comment:**

COGCC Inspection Report Summary

On Tuesday 7/20/2021 at approximately 1100, I, Inspector Scott Ramsey, conducted a routine inspection at XTO/Caerus Freedom unit 297-17A, at Location # 335713 in Rio Blanco county Colorado.

While there, I observed normal production operations. All meters have been calibrated on location within the past year. This location is within or in close proximity to a CPW Density/High Priority Habitat, black bear, NSO habitat and Wildlife Management Area. Operator (Caerus) has provided documentation of their Best Management Practices for Sediment Tracking Controls.

Location still has XTO signage on all signage.

During this inspection the following compliance issues were observed:

1. Staining at well heads
2. Random debris around manifold

Refer to photograph of observed compliance issue.

A follow up on this site inspection will be conducted to ensure the compliance issues have been corrected to comply with COGCC rules. This is a summary of inspection report.
