COGCC Inspection Report Summary  
On Wednesday 7/21/2021 at approximately 1100, I, Inspector Scott Ramsey, conducted a routine inspection at XTO/Caerus Piceance Creek 4603, at Location # 316202 in Rio Blanco county Colorado.  
While there, I observed normal production operations. All meters have been calibrated on location within the past year. This location is within or in close proximity to a CPW Density/High Priority Habitat, black bear, NSO habitat, Wildlife Management Area and BLM stipulations area. Operator (Caerus) has provided documentation of their Best Management Practices for Sediment Tracking Controls.

Location still has XTO signage on all signage.  
During this inspection the following compliance issues were observed:  
1. No battery signage.  
2. One dead man unmarked.  
3. Tank says it is out of service is unused equipment also not labeled.
