INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Wellhead cut and cap operations were completed at the Ludwig 17-5 wellhead location on April 26, 2021. Groundwater and impacted soil were not encountered in the wellhead excavation. Visual inspection and field screening of soils around the well and associated pumping equipment was conducted following wellhead cut and cap operations, and a soil sample was submitted for laboratory analysis to determine if a release occurred. The flowline associated with this wellhead was partially removed on May 4, 2021, and the remaining flowline was abandoned in place and the status will be changed to out-of-service in accordance with Rule 1101.a. (3).A,B,&C. A topographic Site Location Map showing the geographic setting of the site location is provided as Figure 1. Soil sample location and field screening data is presented in Table 1. The wellhead soil sample and field screening locations are illustrated on Figure 2. The flowline field screening locations are illustrated on Figure 3.

On April 26, 2021, a confirmation soil sample (WH-B01@8') was collected from the base of the wellhead cut and cap excavation area at a depth of approximately 8 feet below ground surface (bgs). The soil sample was submitted for laboratory analysis of benzene, toluene, ethylbenzene, and total xylenes (BTEX), naphthalene, and total petroleum hydrocarbons (TPH) - gasoline range organics (GRO: C6-C10) by United States Environmental Protection Agency (USEPA) Method 8260D, TPH - diesel range organics (DRO: C10-C28) and oil range organics (ORO: C28-C40) by USEPA Method 8015D, pH, specific conductance (EC) and sodium adsorption ratio (SAR) by saturated paste method, and boron by hot water soluble soil extract method. Analytical results indicated that constituent concentrations in sample WH-B01@8' were in compliance with COGCC Table 915-1 standards. Soil analytical results are presented in Tables 2 and 3. The laboratory analytical report is provided as Attachment A.

Additional Investigative Actions

- ☐ Additional alternative investigative actions described in attached Site Investigation Plan (summary):

On April 26 and May 4, 2021, visual inspection and field screening of soils was conducted at five sidewall locations within the wellhead cut and cap excavation area, four locations at the ground surface adjacent to the cut and cap excavation, one pothole during partial flowline removal activities, and one additional flowline pothole at the former production facility associated with the Ludwig 17-5 well. Based on the inspection and screening results, hydrocarbon-impacted soil was not present at the soil screening locations. As a result, no soil samples were submitted for laboratory analysis from these areas in accordance with the COGCC Operator Guidance for Oil & Gas Facility Closure document. Soil sample location and field screening data is presented in Table 1. Soil analytical results are presented in Tables 2 and 3. The soil sample and field screening locations are illustrated on Figures 2 and 3. The field notes and a photographic log are provided as Attachment B.

Background soil sample WH-BG01@8' was collected from native material adjacent to the wellhead cut and cap excavation. The background soil sample was submitted for laboratory analysis of the Soil Suitability for Reclamation Parameters using standard methods appropriate for detecting the target analytes in Table 915-1. Analytical results for sample WH-BG01@8' are presented in Table 3.

Laboratory results indicate that constituent concentrations in the soil sample (WH-B01@8') collected from the base of the wellhead cut and cap excavation area were in compliance with COGCC Table 915-1 allowable levels; therefore, no soils were removed. The excavation area was backfilled and contoured to match pre-existing site conditions.

REMEDIATION SUMMARY

Describe how remediation of existing impacts to soil and groundwater is to be accomplished (i.e. summarize remedial action plan). Laboratory results indicate that constituent concentrations in the soil sample (WH-B01@7') collected from the base of the wellhead cut and cap excavation area were in compliance with COGCC Table 915-1 standards. Groundwater was not encountered in the excavation. Based on the analytical data presented herein, assessment is complete at this site and no further activities are required. As such, Kerr-McGee is requesting a No Further Action (NFA) determination for this location.
