Comment:

Well location and well location access road does not comply with Rule 1004. Crops have not been re-established to pre disturbance levels. Crops are not growing in portions of well head footprint and well access road.

Tank battery appears to meet final reclamation regulations and standards, and appear reflective of reference areas. Unable to find evidence of oil and gas activities and/or disturbances. Crop was harvested before site visit, however unharvested crop stalks at the reference site and tank battery were the same height.

Corrective Action: **Comply with Rule 1004. Collaborate with the landowner to determine mitigating measures that will allow reclamation work to be conducted in such a manner as to not interfere with agricultural activities or crop production. Provide documentation within the FIR Resolution form of when the corrective action work will be completed and provide date and documentation of coordination with surface owner. This is a follow-up to previous inspection (doc #697500535) where there was a corrective action (8/27/2019)**
