This group of facilities here were mistakenly excluded from the original transfer list (Form 10), Southland Royalty to MorningStar Partners. These facilities should now go straight from Southland Royalty to MorningStar Operating LLC.
Please Note: Facility ID 479849 was reassigned ID 479522 by the COGCC, and 479522 was transferred to 10753 and a Form 12 is under review for it to transfer to 10755. It is the same situation with Facility ID 479856 - reassigned ID 479548 by the COGCC, and it has transferred to 10753, and there has been a Form 12 filed for transfer to 10755.
